Camera Touch Panel Speaker

Function Button

Charging Port Indicator Microphone Status

Light for Photos

Power On/Off

Power On: Press and hold the right button for 2 seconds

Power Off: Press and hold the right button for 5 seconds

(Note: The device will automatically turn off after 5 minutes without a connection. If the connection is not established, a restart of the device is indicated.)

Pairing with Phone

Scan the code to download the app

Playing Music

Play/Pause: Double tap the touch control area

Skip Tracks: Press and hold the touch control area for 2 seconds to go to the next track; triple tap to go to the previous track

Volume Control

Increase Volume: Slide the right slider forward

Decrease Volume: Slide the right slider backward

Photos/Videos/Recordings

Take a Photo: Press the right physical button once

Record a Video: Press the right physical button twice (when not on a call or playing)

Stop Recording: Press the right physical button once while recording

Start Recording: Press the left physical button twice (when not on a call or playing)

Stop Recording: Press the left physical button once while recording

(Note: 1. Photos, videos, and audio recordings can be transferred via the app. To ensure stable transmission over Wi-Fi, it is recommended to connect the device to a charger before

starting the transfer. 2. To protect the privacy of bystanders while taking photos, recording videos, or capturing audio, a control light is activated as a reminder.)

Activating Voice Assistant

AI Voice Assistant: Press the left physical button once

Phone Voice Assistant: Press and hold the left physical button for 2 seconds

Phone Calls

Answer/End Call: Press the physical button on the left/right side once

Reject Call: Press and hold the physical button on the left/right side for 2 seconds

Charging

Magnetic Charging: A red LED lights up during charging, and a blue LED lights up continuously when fully charged

Factory Reset

Factory Reset: Press and hold the right button for 10 seconds. (Note: This will restore factory settings and erase all data from the glasses.)

Deleting Pairing Information

Delete Pairing Information: Press and hold the left physical button for 7 seconds. (Note: This will erase the pairing information of connected devices.)
