Description

The Freewell Genius Rig for iPhone 17 Pro Max is a professional operator cage designed for mobile creators who want to expand the capabilities of their smartphone. The model is equipped with a quick SnapClamp mounting system that allows you to attach the phone without the use of tools, a magnetic filter slot from Freewell, and a 17 mm thread for mounting compatible lenses. The design offers 11 1/4" mounting threads, 4 cold shoes for connecting additional accessories, and modular TriGenius and MonoGenius handles with a Bluetooth remote. Thanks to its lightweight aluminum construction, 360° rotating handles, and the ability to be used as a tripod, monopod, or selfie stick, the Genius Rig is ideal for vlogging, live streaming, recording materials for YouTube, TikTok, and professional mobile productions.
